SUBORDINATION

This Subordination agreement, made and entered into this 30TH day of JULY, 1992, by and between SOUTHTRUST BANK OF ALABAMA N.A., as Party of the First Part, and COLLATERAL MORTGAGE, LTD., as Party of the Second Part.

THAT, WHEREAS, ROBERT P.
