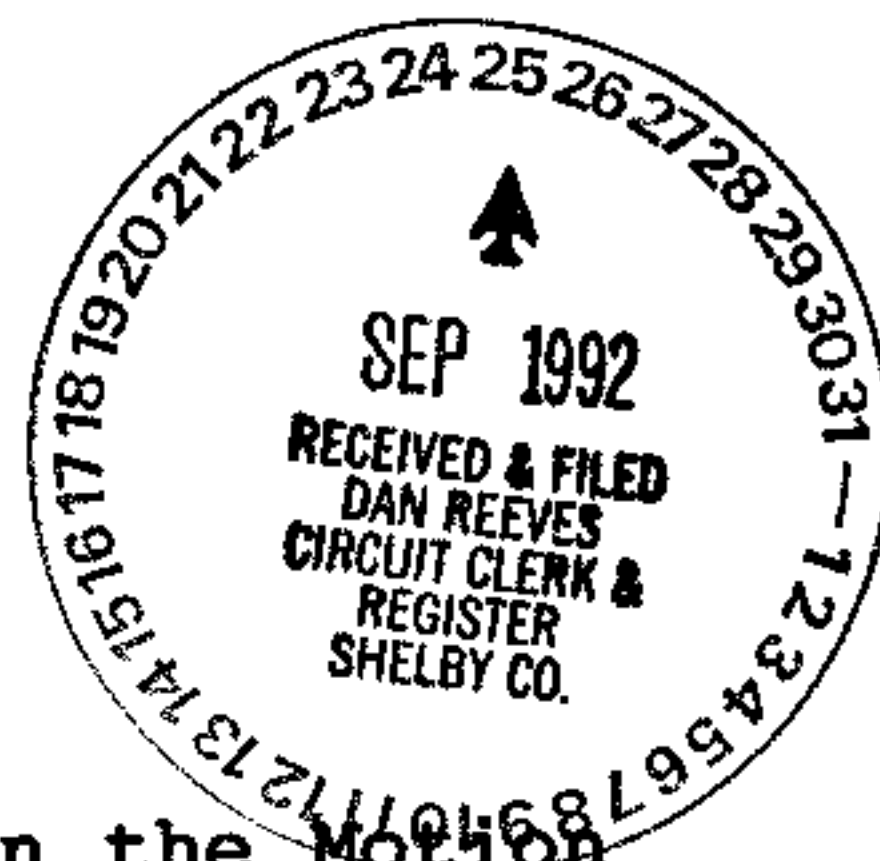

FINAL JUDGMENT

This case has now been submitted for decision on the Motion for Summary Judgment filed by the Plaintiff, Central State Bank of Calera, Alabama. The Motion for Summary Judgment is hereby granted, and it is

ORDERED by the Court as follows:

That the Plaintiff, Central State Bank, have and recover of Defendant, Kenneth Collum, the sum of Twenty-Seven Thousand, Fifty-Nine Dollars and 61/100 (\$27,059.61), plus post-judgment interest from June 25, 1992, at the rate of 13% per annum. This Judgment is entered with waiver of all personal property exemptions of Defendant, Kenneth Collum, as provided by the Constitution and laws of the State of Alabama.

It is further ORDERED by the Court that Plaintiff recover of the Defendant the following property sued for and described in the Complaint, viz:

1972 Buddy 14X61 Mobile Home, SN#785224
1984 Chevrolet, SN#1G1AL69H8H141259
1981 Oldsmobile, SN#1GAR68D8149
1983 Buick, SN#1G4AB69R6DW466324

as claimed in the Complaint in Count Two, said property being in the possession of the Defendant, the alternate value thereof being assessed to the sum of Two Thousand and No/100 Dollars (\$2,000.00) for the mobile home and Two Hundred and No/100 Dollars (\$200.00) for each of the automobiles therein described.

It is further considered and ORDERED by the Court that if Plaintiff recover the property described in this judgment, then the money judgment shall be reduced to the extent of the alternate value of said property as ascertained by this Judgment.

It is further ORDERED by this Court that the Plaintiff recover of the Defendant the following property sued for and described in the Complaint in Count Four, viz:

1976 Ford Model F378Y Wrecker Truck
SN#F37YNB81963

as claimed in the Complaint, said property being in possession of the Defendant, the alternate value thereof being assessed to be the sum of Four Thousand and No/100 Dollars (\$4,000.00).

It is further considered and ORDERED that if Plaintiff recovers the property described in this Judgment, then the money judgment shall be reduced to the extent of the alternate value of said property as ascertained by this Judgment.

Costs of Court are to be taxed to the Defendant.
