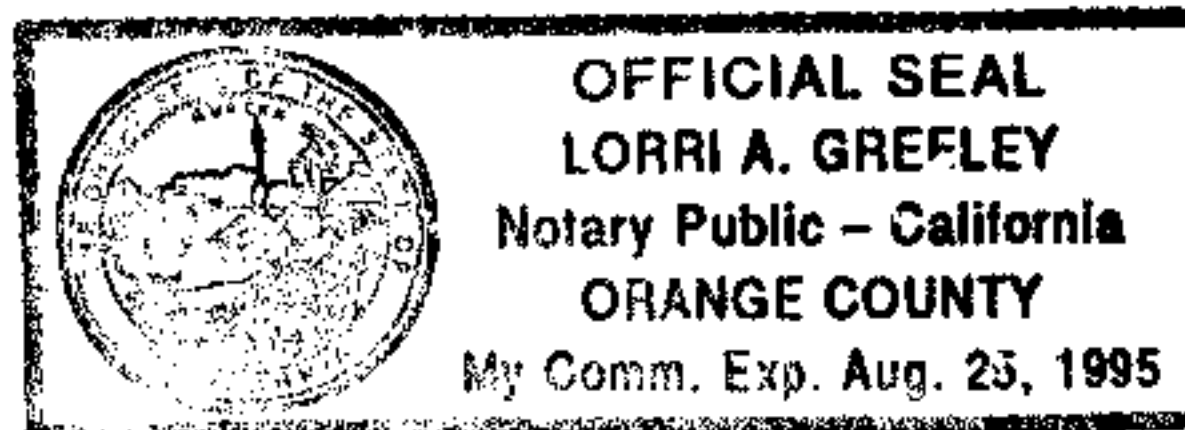

## POWER OF ATTORNEY
