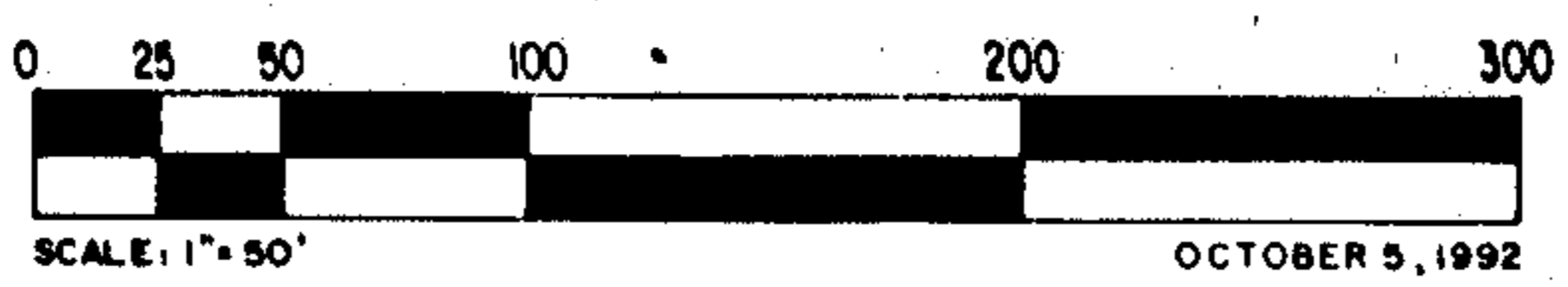


PLANTATION SOUTH THIRD SECTOR PHASE IV
