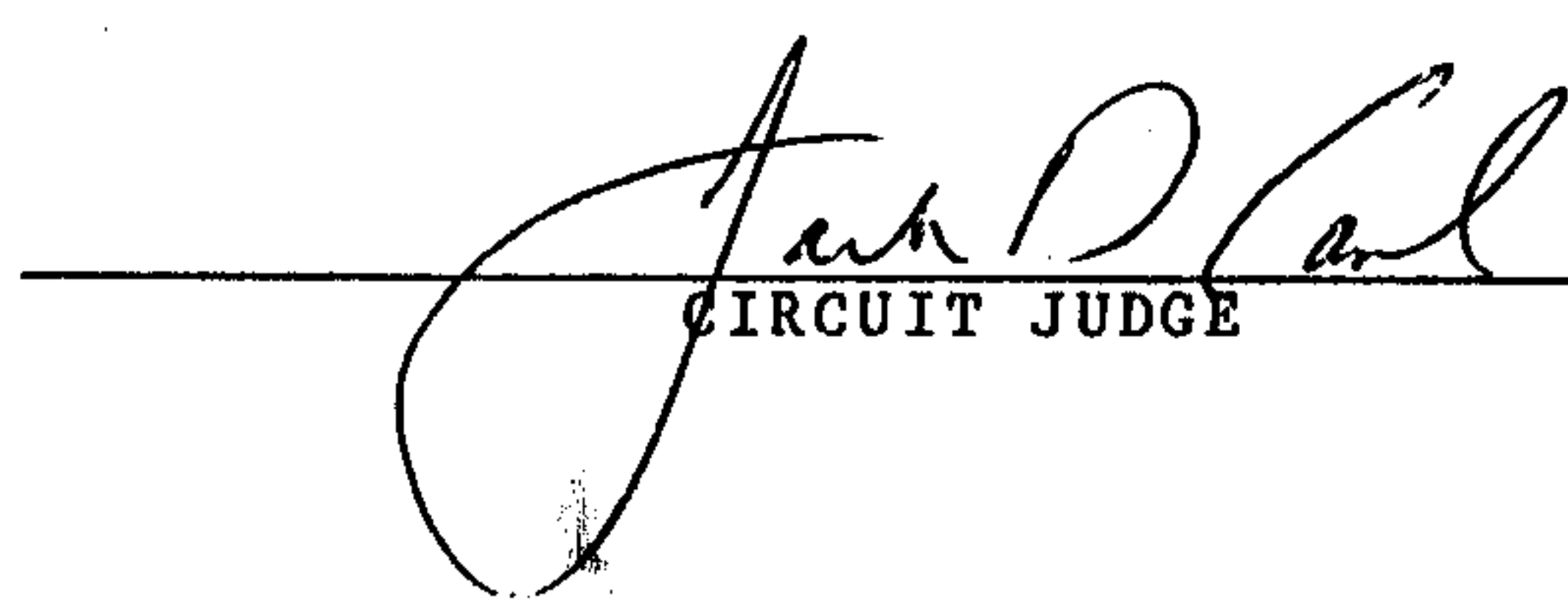

SUMMARY JUDGMENT

This cause came on to be heard upon the "Motion For Summary Judgment" filed by Plaintiff, Jimmy R. Johnson Electric Co., Inc., on March 19, 1992, and after hearing statements and arguments of counsel, the Court finds that the following decretal orders are due to be entered.

It is, therefore, ORDERED, ADJUDGED and DECREED by the Court that the "Motion For Summary Judgment" is granted and judgment is hereby rendered in favor of Plaintiff, Jimmy R. Johnson Electric Co., Inc., and against Defendant, Cooper & Son Construction Company, Inc., in the amount of ONE HUNDRED SIX THOUSAND THREE HUNDRED FORTY NINE AND 74/100 DOLLARS (\$106,349.74), which is EIGHTY TWO THOUSAND THREE HUNDRED SIX AND 20/100 DOLLARS (\$82,306.20) principal, ELEVEN THOUSAND FOUR HUNDRED THIRTEEN AND 79/100 DOLLARS (\$11,413.79) interest up until April 1, 1992 and TWELVE THOUSAND SIX HUNDRED TWENTY NINE AND 74/100 DOLLARS (\$12,629.74) attorney's fee.
