Pursuant to the provisions of Section 10-2A-95 of the Code of Alabama (1975), the undersigned Corporation adopts the following Articles of Correction to its Articles of Incorporation in order to correct an error or omission in the Corporation's Articles of Incorporation:

FIRST: The name of the Corporation is WATER PLUS CORPORATION.

SECOND: The following amendments to the Articles of Incorporation are supplied by the Chairman of the Board and the President of the Corporation, in the manner prescribed by the Alabama Business Corporation Act.

## ARTICLE SIX

## AUTHORIZED SHARES

Section 6.1 <u>Authorized shares</u>. The total number of shares which the Corporation shall have authority to issue shall be Two Thousand (2,000) shares of common stock of the par value of One Dollar (\$1.00) per share. Each shareholder

may have his or her share issued (a) in his or her individual name, or (b) in the names of two or more persons as joint tenants with right of survivorship and not as tenants in common, or (c) as tenants in common.

The number of shares issued and outstanding and the number of shares entitled to vote on the resolution at the time of adoption was One Thousand (1,000) shares. All shares were voted unanimously in favor of the resolution to amend the Articles of Incorporation.

THIRD: The number of shares of the Corporation outstanding at the time of such adoption was One Thousand (1,000); and the number of shares entitled to vote thereon was One Thousand (1,000).

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:


