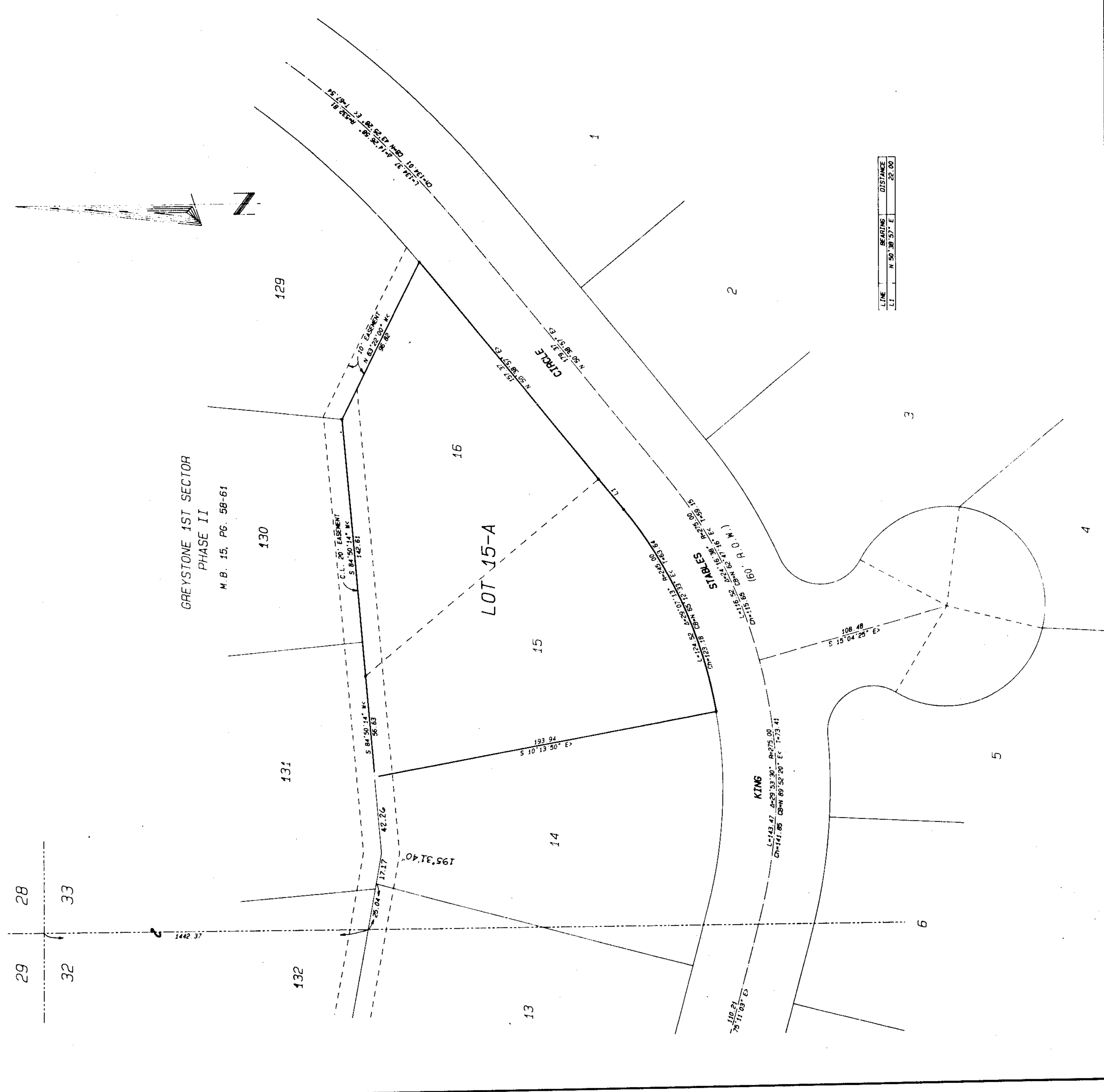


A RESURVEY OF LOTS 15 & 16 OF

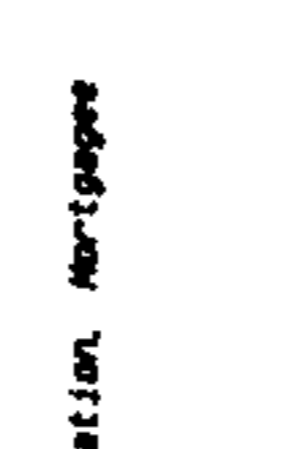
