Further, the Grantee, its successors and assigns hereby acknowledges that the Grantor shall not be liable for and no action shall be asserted against Grantor in connection with any drainage easements, ditcehs or pipes or drainage problems associated therewith and that Grantee has inspected the same and accepts the property along with the drainage easements, ditches or pipes in their present "AS IS" condition.
