KNOW ALL MEN BY THESE PRESENTS

THAT FOR AND IN CONSIDERATION of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, that Curtis Wayne Payne, an unmarried man, Frank Payne, Jr., a single man, Betty Jo Harless, a married woman, James L. Payne, a married man, individually and in their capacity as the heirs at law of Frank Payne and Mary Agnes Payne, deceased, hereinafter called the Grantor, whether one or more, does hereby grant, bargain, sell and convey unto Betty Jo Harless and John B. Harless, as joint tenants, with right of survivorship, hereinafter called Grantee, whether one or more, in fee simple, the following described real estate situated in Shelby County, Alabama, to-wit:

Commence at the southwest corner of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 16, Township 21 south, Range 3 west, Shelby County, Alabama and run thence easterly along the south line of said quarter-quarter section 360.02' to the point of beginning of the property, TRACT III, being described; Thence continue along last described course 355.16' to a point; Thence turn 94°21'45" left and run northerly 294.28' to a point; Thence turn 89°01'04" left and run westerly 183.66 to a point; Thence turn 89°02'39" right and run northerly 208.61' to a point; Thence turn 90°55'24" right and run easterly 208.61 to a point; Thence turn 90°56'11" right and run southerly 208.73' to a point; Thence turn 95°49'40" left and run easterly 205.92' to a point; Thence turn 82°19'03" left and run northerly 335.38' to a point; Thence

turn 91°26'22" left and run westerly 215.77' to a point; Thence turn 0°37'57" right and run westerly 215.90' to a point; Thence turn 88°53'55" right and run northerly 365.98' to a point on the southerly right of way line of SHELBY COUNTY HIGHWAY No. 26 (AKA Kent Dairy Road) in a curve to the left having a central angle of 4°09'18" and a radius of 2,174.97'; Thence turn 91°00'15" left to chord and run westerly along said right of way line an arc distance of 157.66' to a point; Thence turn 88°38'29" left from chord and run southerly 991.63' to the point of beginning, containing 7.39 acres.

This property does not constitute the homestead of any married grantor herein.


TO HAVE AND TO HOLD to the said Grantee and his heirs and assigns in fee simple forever.


