David A. Diestelhorst

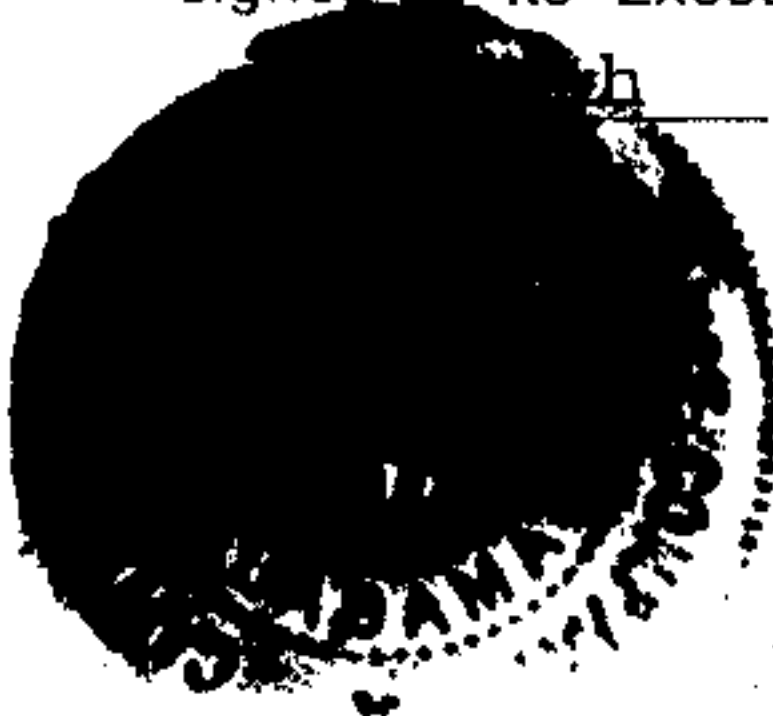
