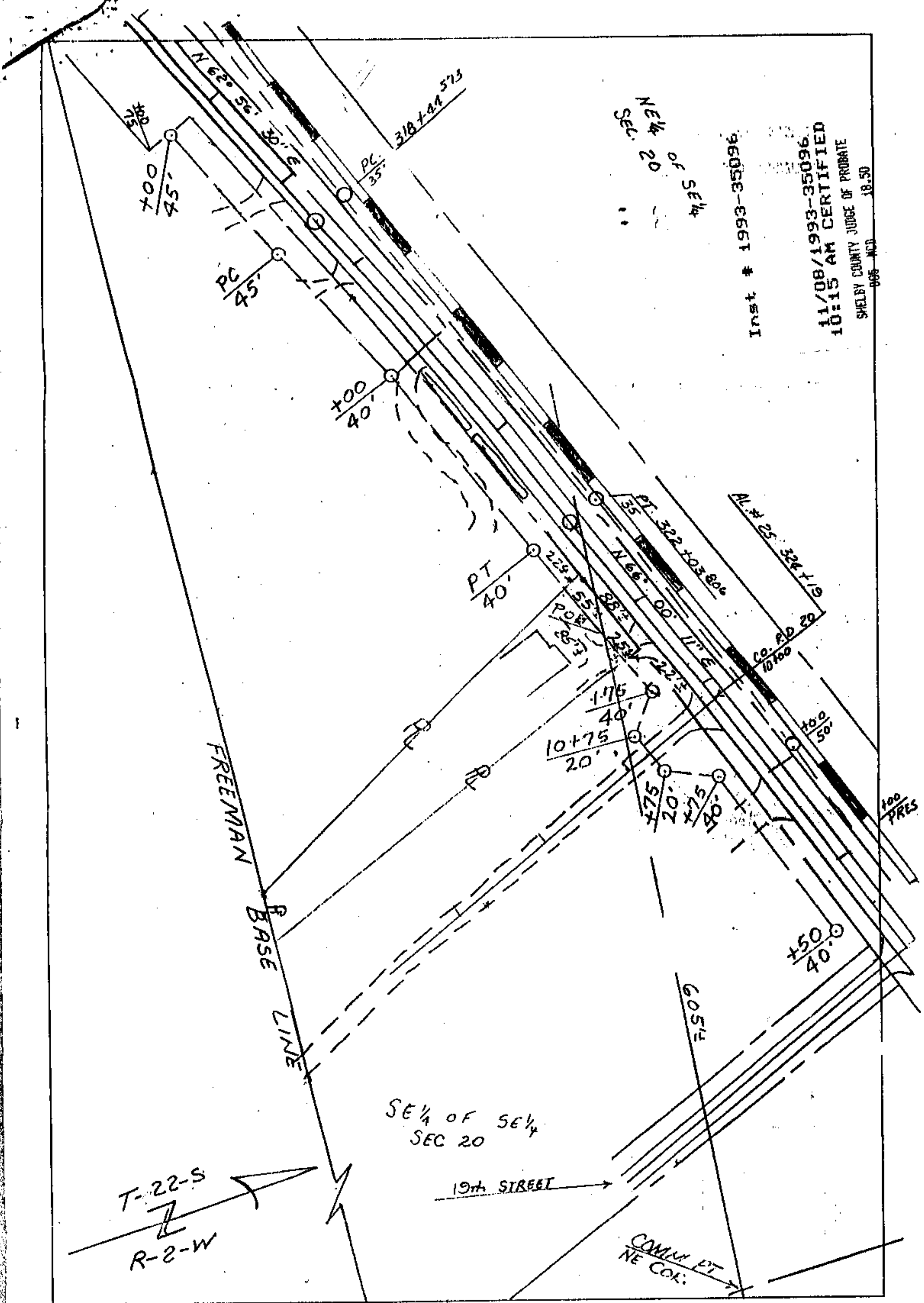

Commencing at the northeast corner of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 20, T-22-S, R-2-W; thence westerly along the north line of said SE $\frac{1}{4}$ of SE $\frac{1}{4}$, a distance of 605 feet, more or less, to a point that is 40 feet southeasterly of and at right angles to the centerline of Project No. S-44-10 and the point of beginning of the property herein to be conveyed; thence S 66° 00' 11" W, parallel with the centerline of said project, a distance of 55 feet, more or less, to the west property line; thence northerly along said west property line, a distance of 22 feet, more or less, to the present southeast right-of-way line of Alabama Highway No. 25; thence northeasterly along said present southeast right-of-way line, a distance of 88 feet, more or less, to the east property line; thence southerly along said east property line, a distance of 22 feet, more or less, to a point that is 40 feet southeasterly of and at right angles to the centerline of said project; thence S 66° 00' 11" W, parallel with the centerline of said project, a distance of 25 feet, more or less, to the point of beginning.
