That in consideration of ONE HUNDRED NINETY SIX THOUSAND SIX HUNDRED FIFTY & NO/100---- (\$196,650.00) DOLLARS to the undersigned grantor, J. D. Scott Construction Co., Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Kenneth W.
