- My full name is Robert Eugene Sult; and,
- I was natural born on July 5, 1948, in Virginia, one of the several States of the united States of America; and,
- 3. I am a free white male Citizen in Shelby County, of Alabama, as evidenced by the "Public Notice Positive Identification of Robert Eugene Sult", which is a matter of public record in Shelby County Recorder's Office, located at the Shelby County Courthouse in the city of Columbiana, in Shelby County, of Alabama, recorded Inst.# 1993-36561, incorporated herein by this reference as if fully set out herein; and,
- 4. I have made my permanent place of abode in Alabama since 1974 and have made Shelby County my permanent place of abode for approximately the last 5 years and therefore am a Soverign Citizen; and,
- 5. I am not a Federal Citizen by virtue of the Fourteenth Amendment; and,
- 6. I am not now, nor have I ever, knowingly entered into any personal internal or private agreement, contract, stipulation, account or similar contrivance with any State, the United States, the District of Columbia, their territories agencies, assigns or affiliates, or other property appertaining thereto; and,

This affidavit is made in good faith and is intended to establish my place of abode under the venue established by the Organic Law of the united States of America and Alabama, to maintain, and to assist in retaining, the Sovereighty of "WE THE PEOPLE" in Alabama against the encroachment of the legislative powers of the United States Congress, exercised by their regional agents;

Any further deprivation of my vested Rights as American Citizens by any governmental agent(s) or agency(ies) will be, by its taking place, deprivation of Mixed War of codified statutory law and common law, waged against me, by whatever person or entity who might commit such trespass and will be remedied by whatever action is necessary and lawful taking into account the moral gravity of the deprivations in the particular instance; and,
- 18. The statements and informaton contained herein are true and correct to the best of my knowledge; are set forth for cause, superseding all denials of afmentioned made to date; and my signature and seal hereafter are the voluntary act of my own hand; and,
