Said parcel is subject to any and all easements, rights -of-way, limitations and /or restrictions of probated record or applicable law, including but not limited to ingress and egress by way of an unimproved road which passes through the southeast portion of the property and utilities which lie adjacent to this road and which serve this parcel and adjacent properties, together with tenements, hereditaments, and appurtenances thereto belonging, and reversions, remainders, rents, issues, and profits, if any, thereof.


