COME NOW the Affiants herein, Joyce Haynie (also known as Joyce Harris Haynie), Rosemary Allen (also known as Rosemary Haynie Allen), and Philip Doyle Haynie, and after first having been duly sworn, said Affiants do hereby depose and say as follows:

1. That each of the Affiants have personal knowledge of the facts stated herein, and are over the age of nineteen (19) years, and of sound mind.




