KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED ELEVEN AND NO/100 DOLLARS (\$111,000.00 ), to the undersigned grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **MICHAEL H. COLLINS AND WIFE, NANCY COLLINS** (herein referred to as Grantors) do grant, bargain, sell and convey unto **MICHAEL R. BARRETT AND JAIMEE K. BARRETT** (herein referred to as Grantees), as tenants in common with equal rights and interest for the period or term that the said Grantees shall both survive, and unto the survivor of the said Grantees, at the death of the other, and to the heirs and assigns of such survivor in fee simple forever, such tenancy expressly intended to create co-tenants in common for life with a contingent remainder in fee in favor of the survivor of the said Grantees, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:

Lot 15 except the West 5 foot, according to the Survey of Hamlet, Fourth Sector, as recorded in Map Book 9, page 22, in the Probate Office of Shelby County, Alabama.

Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.



\$88,800.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

And we do for ourselves and for our heirs, executors, and administrators covenant with said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall, warrant and defend the same to the said Grantees, their heirs, and assigns forever, against the lawful claims of all persons.
