Sage, separately and severally, are to pay attorney's fees in the amount



of FORTY-ONE THOUSAND, NINE HUNDRED, FIFTY-NINE AND 53/100 DOLLARS (\$41,959.53); plus interest at the rate of 3.57% percent per annum (3.57% APR) and costs in the amount of ONE THOUSAND, FIVE HUNDRED, SEVENTY-NINE AND 53/100 DOLLARS (\$1,579.53); it was FURTHER ORDERED by the court that payment of the proceeds of the judgement, interest and costs herein may be made directly to the attorneys of record for the plaintiff, Gordon, Silberman, Wiggins & Childs, P. C., and that upon receipt thereof, such attorney will satisfy said judgement on the records of this Court.
