SECTION 4.7. Vice Presidents and Trust Officers.

Each Vice President and Trust Officer shall have all of the powers vested in any Trust Officer or Assistant Trust Officer, and in addition is empowered to execute all deeds, conveyances, mortgages, contracts, bonds, bills of sale, trust or agency agreements, indentures or deeds of trust, notes, assignments, powers of attorney or of substitution, or any other instrument incident to the acceptance of any trust, or the pledge, sale or other disposition of any property, rights or powers held or controlled by the bank in any fiduciary capacity; to purchase, sell, pledge, or otherwise dispose of stocks, bonds or any other securities, or property of any kind, real or personal, for trust accounts; and to perform such other duties as may be authorized by the Board of Directors, Executive Committee, or Trust Committee.

Any officer who may be designated as Senior Vice President and Trust Officer or Vice President and Investment Officer or Vice President and Senior Trust Investment Officer or Vice President and Real Estate Officer shall have the same powers as a Vice President and Trust Officer, and such other authority and responsibility as may be provided by the Board of Directors, the Trust Committee or by the Head of the Trust Department.

SECTION 4.8. Trust Officers and Assistant Trust Officers.

Each Trust Officer and Assistant Trust Officer and any other officer of this Bank assigned to work in the Trust Division of this Bank shall have the power to execute all certificates, releases, satisfactions, authentications (including authentication of bonds), proxies, leases (including oil, gas and other mineral leases), transfers, receipts, agreements or other instruments pertaining to or incident to the management or handling of any property, rights or powers held or controlled by the bank in any fiduciary capacity, or pertaining to or incident to the management or handling of any trust accounts under the supervision or management of the bank.
