**AMENDMENT TO THE
DECLARATION OF PROTECTIVE COVENANTS
OF
BROOK HIGHLAND,
a Residential Subdivision**

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Eddleman & Associates, an Alabama general partnership, has previously filed a Declaration of Protective Covenants in the Probate Office of Shelby County, Alabama, in Real Volume 194 at page 254 (the "Original Declaration") for the benefit of certain real property situated in Shelby County, Alabama, commonly known as Brook Highland;

WHEREAS, the Tenth Sector of Brook Highland (the "Tenth Sector"), more particularly described in the Plat of Brook Highland Tenth Sector, First Phase and the Plat of Brook Highland Tenth Sector, Second Phase, as recorded in Map Book 17 at page 108 and Map Book 18 at pages 36A and 36B in the Probate Office of Shelby County, Alabama, respectively, was submitted to the Original Declaration by the Supplemental Declaration of Protective Covenants of Brook Highland, a Residential Subdivision, Tenth Sector, First Phase and the Supplemental Declaration of Protective Covenants of Brook Highland, a Residential Subdivision, Second Phase, as recorded as Instruments Numbered 1993-31073 and 1993-06901, respectively (the "Supplemental Declarations");

WHEREAS, Eddleman Properties, Inc. ("Developer") has succeeded to the rights of the Developer (as defined in Section 1.03 of the Original Declaration) and desires to amend the Original Declaration, as heretofore amended by the Supplemental Declarations, to provide a special assessment for the installation, repair, maintenance, operation and replacement of a street lighting system in the Tenth Sector under the authority of Section 10.01 of the Original Declaration; and

WHEREAS, the imposition of the special assessment will require the consent of each of the Owners of Lots in the Tenth Sector and NCNB (as such terms are defined in Sections 1.08, 1.05 and 1.06, respectively, in the Original Declaration) by reason of Section 10.03 of the Original Declaration;

NOW, THEREFORE, THESE PREMISES CONSIDERED, the Developer does hereby amend the Original Declaration with respect to the Tenth Sector as follows:

1. Section 4.07 of the Original Declaration is hereby amended to provide for the allocation of a Special Assessment against the Owners of Lots in the Tenth Sector by deleting Section 4.07 in its entirety therefrom and substituting in lieu thereof the following:

Section 4.07 Allocation of Assessments.

(a) The Board shall allocate a portion of each Assessment to each Lot in the proportion that each Lot bears to the total number of Lots within the Property (to the nearest one-thousandth).

(b) Notwithstanding the foregoing, the Board shall have the authority to allocate a special assessment for the installation repair, maintenance, operation and replacement of a street lighting system in the Tenth Sector (described in the plats of the First and Second Phase of the Tenth Sector of Brook Highland recorded in Map Book 17 at page 108 and Map Book 18 at page 36A and 36B) among the Lots in said Tenth Sector in equal shares. No other Lot in the Property shall be subject to the payment of the Special Assessment authorized under this subparagraph.

2. Eddleman Properties, Inc. has joined in the execution of this Amendment to the Original Declaration (the "Amendment") not only for the purpose of effecting the Amendment as the Developer under the authority of Section 10.01 of the Original Declaration, but also to evidence its consent thereto as the Developer pursuant to Section 10.03(e) of the Original Declaration. The Owners of all of the Lots of the Tenth Sector have joined in the execution of this Amendment to evidence their consent thereto as required by Section 10.03(a) of the Original Declaration. AmSouth Bank N.A. as Ancillary Trustee for NationsBank of North Carolina N.A. as Trustee for the Public Employees Retirement System of Ohio has joined in the execution of this Amendment to evidence the consent of NCNB thereto as required by Section 10.03(f) of the Original Declaration.

3. Except as amended hereby, the undersigned hereby ratify, confirm and approve the terms and conditions of the Original Declaration as heretofore amended.
