If this Mortgage is subordinate to a Prior Mortgage, the Mortgagor expressly agrees that if default should be made in the payment of principal, interest or any other sum payable under the terms and provisions of the Prior Mortgage, or if any other event of default (or event which upon the giving of notice or lapse of time, or both, would constitute an event of default) should occur thereunder, then and in such event or events the Mortgagee may, but shall not be obligated to, cure such default, without notice to anyone, by paying whatever amounts may be due, or taking whatever other actions may be required, under the terms of the Prior Mortgage so

The Mortgagor agrees that no delay or fallure of the Mortgages to exercise any option to declare the Debt due and payable shall be deemed a waiver of the Mortgagee's right to exercise such option, either as to any past or present default, and it is agreed that no terms or conditions contained in this Mortgage may be walved, altered or changed except by a written instrument signed by the Mortgagor and signed on behalf of the Mortgages by one of its officers.

The Mortgagee may terminate the Agreement and accelerate payment of the outstanding balance thereof prior to the scheduled

expiration date of the Agreement if:

- There has been fraud or material misrepresentation by the Borrower in connection with the Agreement, including (a) fraud or misrepresentation (whether by acts of omission or overt acts) during the application process or at any other time when the Agreement is in effect;
- The Borrower fails to make any required payment under the Agreement or this Mortgage when due; or (b)
- Any action or inaction by the Borrower adversely affects the Real Estate, or any right of the Mortgages in such (c) Real Estate.
