(\$104,050.00) DOLLARS to the undersigned grantor, Scott Development Co., Inc. a

herein, the receipt of which is hereby acknowledged, the said GRANTOR does by
these presents, grant, bargain, sell and convey unto Kevin M. Greene and wife, Lee
Ann Greene (herein referred to as GRANTEES) for and during their joint lives and
upon the death of either of them, then to the survivor of them in fee simple,
together with every contingent remainder and and right of reversion, the following
described real estate, situated in Shelby County, Alabama:
