"AmSouth Premium Line of Credit Agreement" executed by the Borrower in favor of the Mortgagee dated _, 19<u>95</u>, as amended by an amendment of even date herewith.

The Credit Agreement provides for an open-end line of credit pursuant to which the Borrower may borrow and repay, and repay, amounts from the Mortgagee up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- B. Rate and Payment Changes. The Credit Agreement provides for finance charges to be computed on the unpaid balance outstanding from time to time under the Credit Agreement at an adjustable annual percentage rate. The annual percentage rate may be increased or decreased on the first day of each billing cycle based on changes in the "Prime Rate" as published in the Wall Street Journal. The annual percentage rate charged under the Credit Agreement during each billing cycle will be 2.00% above the Prime Rate in effect on the first day of that billing cycle. The annual percentage rate on the date of this mortgage is 11.00%. The annual percentage rate will increase if the Prime Rate in effect on the first day of a billing cycle increases, and will decrease if the Prime Rate in effect on the first day of a billing cycle decreases; however, the annual percentage rate will never exceed the Maximum Rate stated in the Credit Agreement. The Mortgagee is hereby authorized on behalf of, and in the name of, the Mortgager to execute and deliver valid acquaintances for, and appeal from, any such judgments or awards.
