That in consideration of ONE DOLLAR (\$1.00) and other good and valuable consideration and exchange of deeds, to the undersigned grantors, in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, we, Jimmie Roland Spates, a married man; Alvin George Spates, an unmarried man; Roosevelt Spates, a married man; Tera R. Rodgers, a married woman; Enoch C. Canterbury, an unmarried man; and Terrie L. McKinnon, a married woman (herein referred to as grantors), do grant, bargain, sell and convey unto Jimmie Roland Spates (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:

The S 1/2 of the NW 1/4 of the NE 1/4 of Section 35, Township 19, Range 2 East, Shelby County, Alabama.

SUBJECT TO a non-exclusive 30-foot right of way and utility easement reserved by grantors along the entire Eastern boundary of the above described property.

The above described property does not constitute any part of the homestead of the grantors or their spouses.




