Commence at the Southeast corner of the NW 1/4 of SE 1/4 of Section 26, Township 20, Range 3 West; thence run along the South line of said 1/4 - 1/4 Section a distance of 210 feet to the point of beginning; thence continue along said line a distance of 260.41 feet to a point; thence turn right 100 deg. 52 min. 06 sec. and run in a Northerly direction 459.74 feet; thence turn right 79 deg. 07 min. 22 sec. and run Easterly a distance of 99.43 feet to a point; thence turn right 94 deg. 07 min. 40 sec. and run in a Southerly direction a distance of 242.05 feet to a point; thence turn left 94 deg. 04 min. 30 sec. and run East a distance of 87.41 feet to a point; thence turn right 88 deg. 47 min. 22 sec. and run South a distance of 210 feet to the point of beginning.
