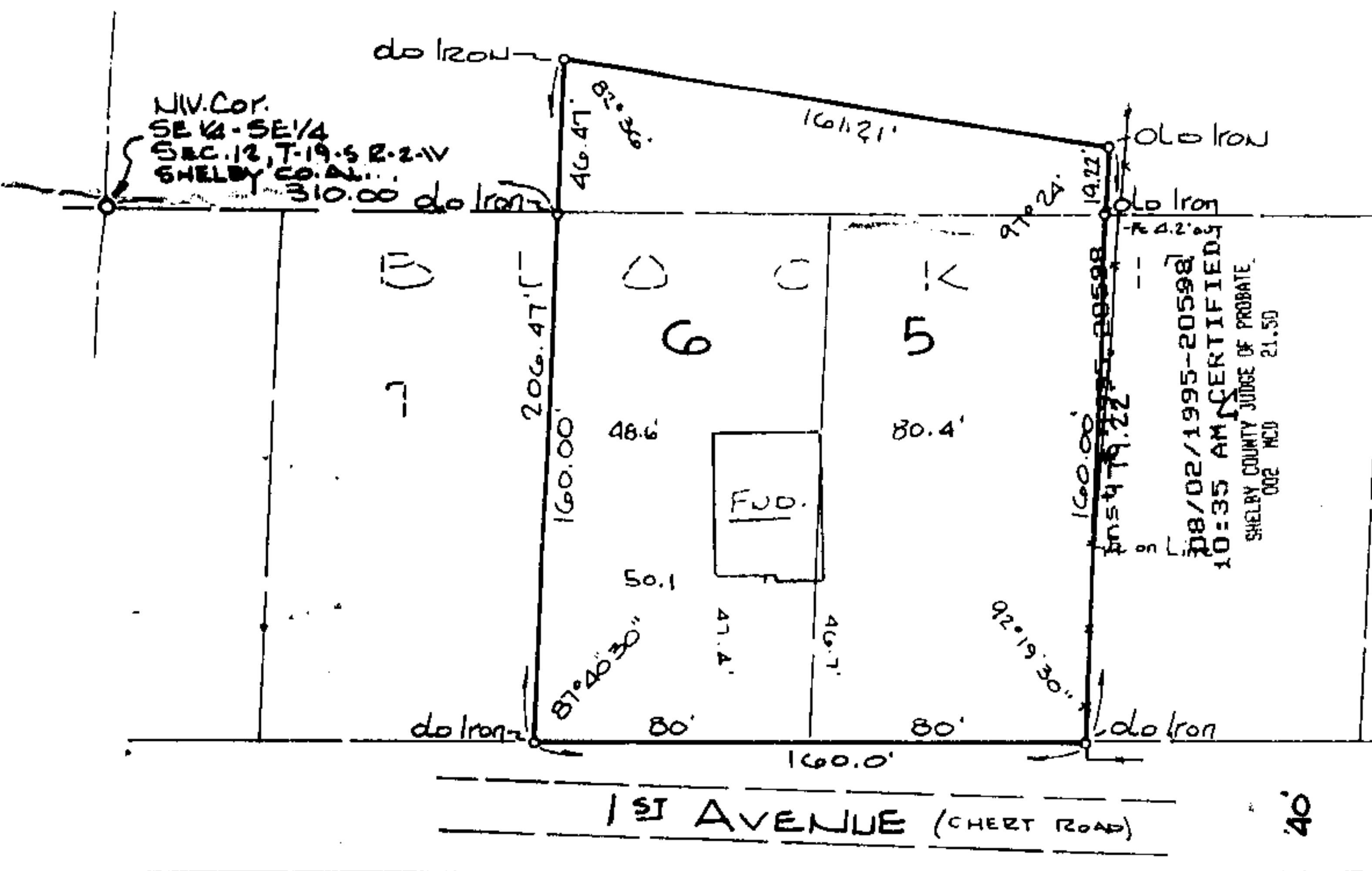

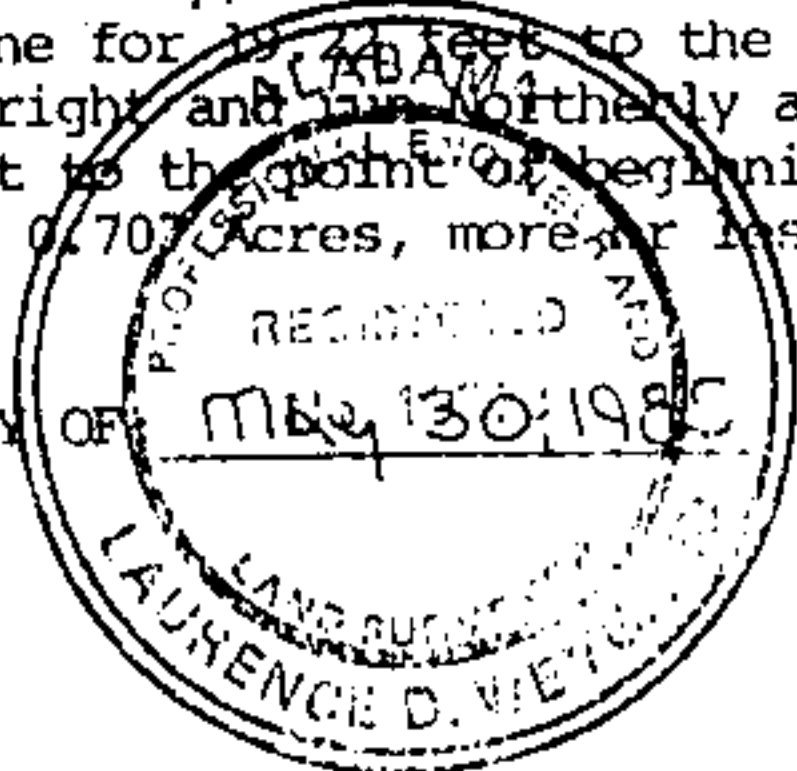

I, Laurence D. Weygand, Registered Engineer-Land Surveyor, certify that I have surveyed the land shown hereon and described below; that there are no rights-of-way, easements, or joint driveways over or across said land visible on the surface except as shown; that there are no electric or telephone wires (excluding wires which serve the premises only) or structures or supports therefor, including poles, anchors and guy wires, on or over said premises except as shown; that there are no encroachments on said land except as shown; that I have consulted the Federal Insurance Administration Flood Hazard Boundary Map and found that this property is not located in a special flood hazard area; that improvements are located as shown above, and that the correct description is as follows:

A parcel of land consisting of Lots 5 and 6, Block 17 according to the survey of LINCOLN PARK, a subdivision in Shelby County, Alabama, being situated in the South 1/2 of Section 12, Township 19, Range 2 West; ALSO, the following described acreage lying East of and adjacent to said Lots 5 and 6: BEGIN at the Northeast corner of Lot 6 according to said survey; thence run Easterly along the projected North line of said Lot 6 for 46.47 feet; thence 97° 24' right and run Southwesterly 161.21 feet to a point on the projected South line of Lot 5 of said survey; thence 82° 36' right and run Westerly along said projected lot line for 15.44 feet to the Southeast corner of said Lot 5; thence 87° 40' 30" right and run Northerly along the East line of said Lot 5 and 6 for 160.0 feet to the point of beginning. Said parcel contains 30, 830.13 Square Feet or 0.707 Acres, more or less.
