To be a team in our religious endeavors, not an individual. To open our doors, and welcome all people - all races - in our fellowship and in our Church offices (S.S. Teacher, Supt., Assoc. Pastor, Deacons, Choir Directors, Musicians) and any other position that may be available. Our utmost endeavor is to join the believers in the Love of God to be a Brotherhood working in unity - giving each sincere believer a chance to make their calling and election sure.
