PARTIAL RELEASE AND AMENDMENT TO MORTGAGE

WHEREAS, the undersigned CREST RIDGE ASSOCIATES, L.L.C., an Alabama limited liability company ("Mortgagor") executed and delivered to CREST RIDGE, INC., an Alabama corporation ("Mortgagee") a Mortgage and Security Agreement dated June 7, 1994 (the "Mortgage"), which Mortgage was recorded in Instrument 1994-18517, in the office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, the Mortgagee and the Mortgagor have agreed to release from the Mortgage the following parcels of property (the "Released Parcels"):

Lots 16, 17 and 18 according to the Survey of The Crest at Greystone, First Addition, as recorded in Map Book 19, page 52 in the Probate Office of Shelby County, Alabama.

and to substitute in lieu of the Released Parcels to become a part of the Mortgaged Property, as defined in the Mortgage, the following parcels of property (the "Replacement Parcels"):

Lots 1, 3, 12 and 13, according to the survey of The Crest at Greystone, Second Addition, as recorded in Map Book 19, Page 53 in the Probate Office of Shelby County, Alabama.

NOW, THEREFORE, Mortgagor and Mortgagee hereby agree as follows:

1. That the Mortgagee does hereby release, remise, convey and quitclaim unto the said Mortgagor, its successors and assigns the Released Parcels from the lien, operation and effect of the Mortgage.

As to all other Mortgaged Property described and conveyed in said Mortgage, the lien thereof shall remain in full force and effect.

2. That the Mortgage is hereby amended to include in the Mortgaged Property the Replacement Parcels, the same as if they had been included as part of the Mortgaged Property when the Mortgage was executed on June 7, 1994, and recorded on June 9, 1994, in 1994-18517 in the Office of the Judge of Probate of Shelby County, Alabama.
