

WARRANTY DEED WITH RIGHT OF SURVIVORSHIP

That in consideration of TWO HUNDRED FORTY-SIX THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$246,500.00) to the undersigned Grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **PATRICK BRADLEY DAVIDSON AND LANITA WHITTEN DAVIDSON**, husband and wife (herein referred to as Grantors), do grant, bargain, sell and convey unto **DANIEL S. GOLD AND MADELEINE E. GOLD**, as joint tenants with right of survivorship, (herein referred to as Grantees), the following described real estate situated in SHELBY County, Alabama to wit:

Lot 347, according to the survey of Brook Highland, an Eddlemen Community, 7th Sector, as recorded in Map Book 13, Page 99, in the Probate Office of Shelby County, Alabama.
