Amendment to Adjustable-Rate Line of Credit Mortgage

This amendment (the "Amendment") is made and entered into on <u>November 30, 1995</u>, by and between <u>RICHARD W. PATTON AND WIFE</u> <u>CYNTHIA R. PATTON</u> (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, (hereinafter called the "Mortgagee").

- B. The Mortgagor has executed in favor of the Mortgagee an Adjustable-Rate Line of Credit Mortgage (the "Mortgage") recorded in 124 at page 928, in the Probate Office of SHELBY, County, Alabama. The Mortgage secures (among other things) all advances made by the Mortgagee to the Borrower under the Credit Agreement, or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit.

- 1. The term "Credit Limit" as used in the Mortgage shall mean the Amended Credit Limit of FOURTEEN THOUSAND AND 00/100************ Dollars (\$ 14000.00).

Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
