**CERTIFICATE REGARDING TERMINATION OF LEASE AGREEMENT
DATED AS OF OCTOBER 1, 1984 BETWEEN THE INDUSTRIAL
DEVELOPMENT BOARD OF THE CITY OF MONTEVALLO, ALABAMA,
AS LESSOR, AND METROCK STEEL AND WIRE COMPANY, INC., AS LESSEE**

We, the undersigned, hereby certify, acknowledge, attest and provide notice that (i) The Industrial Development Board of the City of Montevallo, Alabama (the "Lessor") and Metrock Steel and Wire Company, Inc. heretofore entered into a Lease Agreement, dated as of October 1, 1989 (the "Lease"), recorded in the Probate Office of Shelby County, Alabama in Volume 8, Page 586, and (ii) the Lease is hereby terminated as a result of the payment in full of the Six Hundred Fifty Thousand and No/100 Dollars (\$650,000.00) The Industrial Development Board of the City of Montevallo, Alabama Industrial Development Revenue Bond (Metrock Project), Series 1984 (the "Bond"), as described in Section 11.1 of the Lease. The Lessor further hereby releases and satisfies, and acknowledges the release and satisfaction of, all liens, encumbrances and security interests arising under or pursuant to the Lease.




