WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HUNDRED THIRTY FOUR THOUSAND NINE HUNDRED & NO/100---- (\$134,900.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, James Browning and wife, Donna Browning (herein referred to as grantors), do grant, bargain, sell and convey unto Worley L. Miller and wife, Mary Ann Miller (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.



\$114,900.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.


