INSTRUCTIONS:

1. 10 1/2' X 36' "unipole" structure approximately 50' high. This structure has two metal faces, three halophane lights, and is located on the West side of I-65 at milepost 234.39L, in Alabaster, Alabama. The state permit is #3-5-288. This structure is located on property owned by Michael Edward Ford, with the land lease being recorded in the Shelby County Judge of Probate's office in Columbiana, Alabama, on October 19, 1993, Reference #10/19/1993-32486, assigned to Jibewe, Inc. on October 15, 1993.
2. 10 1/2' X 36' double stacked single-faced (2 faces) unipole approximately 60' overall height, located on the West side of I-65 in Shelby County at milepost 240.94L in Alabaster, Alabama. This structure is complete with two metal faces and three halophane lights. Permit #3-5-266, sign ID#-59-665-240-94L.
3. 14' X 48' 20' V unipole (2 faces) approximately 75' overall height located on the East side of I-459 in Jefferson County, at milepost 16.74R, near Hoover, Alabama. This structure is complete with two metal faces and eight halophane lights. Permit #-3-1-1176, sign ID#-37-459-16.74R.
