**RELEASE & TERMINATION OF RIGHT-OF-WAY EASEMENT**

WHEREAS, Paul Cost and wife, Lois W. Cost, (hereinafter "*the Costs*") previously granted a thirty foot (30') non-exclusive right-of-way easement to The Alabaster Water & Gas Board (now, The Alabaster Water Board) (hereinafter, "*the Board*") pursuant to that certain instrument filed at Book 010, Page 418, in the Office of the Judge of Probate of Shelby County, Alabama on November 30, 1984 ("*the easement*"); and,

WHEREAS, the Costs and the Board now agree that it is no longer necessary for the Board to enjoy said right-of-way easement to property owned by the Board adjacent to property owned by the Costs,

NOW THEREFORE, know all men by these presents, that in consideration of One dollar (\$1.00) and other good and valuable consideration to the undersigned Board (whether one or more), in hand paid by the Cost's, the receipt whereof is acknowledged, The Alabaster Water & Gas Board hereby releases and terminates the aforementioned easement, more particularly described as the following real estate situated in Shelby County, Alabama, to-wit:

COMMENCE AT THE SOUTHWEST CORNER OF SECTION 14, TOWNSHIP 21 SOUTH, RANGE 3 WEST, THENCE RUN NORTH ALONG THE WEST LINE OF SECTION 14, A DISTANCE OF 1132.01 FEET TO THE POINT OF BEGINNING; THENCE TURN AN ANGLE OF 87 DEG. 53 MIN. 15 SEC. TO THE RIGHT AND RUN A DISTANCE OF 207.39 FEET; THENCE TURN AN ANGLE OF 3 DEG. 53 MIN. 15 SEC. TO THE LEFT AND RUN A DISTANCE OF 571.87 FEET OT THE WEST RIGHT OF WAY OF SHELBY COUNTY HIGHWAY NO. 119 AND THE POINT OF ENDING. SITUATED IN SECTION 14, TOWNSHIP 21 SOUTH, RANGE 3 WEST, SHELBY COUNTY, ALABAMA.
