- The right to purchase or acquire, by gift, bequest, or otherwise, either directly or as trustee, to own, hold in trust, use or otherwise possess, sell, convey, mortgage, lease, or otherwise dispose of such property, real or chattel, as may be needed for the consummation of the organization's work.
