KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE DOLLAR AND FOR THE PURPOSE OF CREATING SURVIVORSHIP (\$1.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **Michael D. Rhodes and wife, Kathie O. Rhodes**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **Michael Rhodes and Kathie Rhodes** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:
