- 17. INSPECTION OF PROPERTY, BOOKS, RECORDS AND REPORTS. - 24. POWER OF ATTORNEY. Mortgagor hereby appoints Lender as its attorney-in-fact to endorse Mortgagor's name on all instruments and other documents pertaining to the Obligations or the Mortgage.
