Property Description

Default

In the event of default under any of the terms or conditions of the said subordinated lien, resulting in foreclosure proceedings thereon, or on the accompanying note, such proceedings shall be especially advertised as being under and subject to the lien and payment of the said Mortgage given and executed by RICHARD LYNN HOLCOMB AND WIFE, CYNTHIA R. HOLCOMB to APCO EMPLOYEES CREDIT UNION ON MAY 13, 1997, in the principal sum of \$75,000.00.
