WHEREAS, The Last Will and Testament of Nannie Dee Durden, deceased, Item 5 (3) provided; "...the separate Trust shall be held for said beneficiaries until such time as each of them has attained the age of 25 years, at which time the said Trust shall cease and determine, and the corpus thereof shall be paid over to the beneficiaries outright and free from Trust..", and,

KNOW ALL MEN BY THESE PRESENTS, that, for and in consideration of the sum of Ten and No/100 (\$10.00) Dollars cash and other good and valuable consideration in hand paid by Alfred Tucker Alley to AmSouth Bank and Lehman Murray Alley as Co-Trustees of the Nannie Dee Durden Trust for the benefit of Alfred Tucker Alley, does hereby remise, release, quit claim and convey unto Alfred Tucker Alley, an undivided 5.5555% interest in the following described property located in Shelby County, Alabama to-wit:

The SE/4 of the SE1/4 East of Highway 31 in Section 20, Township 21 South, Range 2 West. The S1/2 of the SW1/4 of Section 21, Township 21 South, Range 2 West. The N1/2 of the N1/2 of the NW1/4, East of Highway 31 in Section 28, Township 21 South, Range 2 West.
