

COMPLAINT

- 1. Plaintiff, Scaletron Industries, Ltd. is a Pennsylvania Corporation with its principal office located at 53 Apple Tree Lane, Plumsteadville, Bucks County, PA 18949.
- 2. Defendant, Guy E. Boyle, t/a Boyle Water Systems, is believed and therefore averred to be a competent adult individual trading under a fictitious name with his principal place of business located at P.O. Box 1747, 3230 Armstrong Industrial Court, Pelham, AL 35124.
- 3. On or about July 6, 1994, Defendant submitted a credit/dealer application in the form attached hereto as Exhibit "A".
- 4. This credit/dealer application was accepted by Plaintiff, and thereafter, Defendant sold products of Plaintiff with a "dealer discount".
- 5. On or about July 2, 1996, July 3, 1996, August 14, 1996, August 21, 1996 and August 28, 1996, invoices in the form attached hereto as Exhibits B-1, B-2, B-3, B-4 and B-5 were issued by Plaintiff to Defendant as a result of Defendant's orders for those materials.

6. These materials were shipped by Plaintiff to Defendant in the ordinary course of Plaintiff and Defendant's business.

7. Thereafter, despite Defendant's receipt of these items, Defendant has refused to remit the amounts claimed by Plaintiff resulting from Exhibits "B-1" through "B-4". Thereafter, on October 22, 1996, the invoice attached hereto as Exhibit "C" was issued by Plaintiff to Defendant.

8. The amount referred to in Exhibit "C" is unpaid as of the date of this Complaint and interest at the rate of 1.5% per month is properly charged to Defendant by Plaintiff pursuant to the terms of Exhibit "A".

9. Plaintiff has incurred reasonable attorney's fees in the amount of \$500.00 and Court costs of \$125.50 to date, and additional legal fees and expenses will be incurred in the future in this matter.

10. Despite Plaintiff's continuing demands, Defendant has failed to remit payment of the balance due on Exhibit "C". The current balance due by Plaintiff to Defendant is as follows:

Total \$9,326.65

WHEREFORE, Plaintiff demands judgment against Defendant in the amount of \$9,326.65, plus interest at 1.5% per month from October 22, 1996, plus attorney's fees and costs, an amount not in excess of that requiring compulsory arbitration in this jurisdiction.


