Weygand; thence turn an angle to the right of 24 degrees 34 minutes 52 seconds and run in a northwesterly direction for a distance of 194.42 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the right of 51 degrees 49 minutes 22 seconds and run in a northwesterly direction for a distance of 52.96 feet to an existing iron rebar set by Laurence D.
