MODIFICATION AGREEMENT

This MODIFICATION AGREEMENT is made and entered into this 19th day of December 19 97, by and between THOMAS JERRY GILLESPIE JR MARTHA GILLESPIE

(hereinafter referred to as "Borrower"), and REGIONS BANK
(hereinafter referred to as "Lender") for the property located at 500 SEVEN OAKS PARK

WHEREAS, Borrower executed a note (the "Note") in favor of the Lender dated 03/19/97, in the original principal amount of \$ 216,550.00; and

WHEREAS, Borrower executed a mortgage, deed of trust or security deed (the "Security Instrument") dated 03/19/97, in favor of the Lender securing the indebtedness evidenced by the above referenced Note with a parcel of land described on Exhibit "A" attached hereto and incorporated herein by reference and being more particularly described in said Security Instrument; and

WHEREAS, the above referenced Security Instrument was recorded in INSTRUMENT # 1997, Page 9138, of the Shelby County/Parish, Alabama, records on 3/25/97 and

WHEREAS, the parties now desire to amend and modify the Note and the Security Instrument to provide for changes in the terms;

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is herein acknowledged, the parties do herein agree to the modification of the Note and the Security Instrument as herein set forth:
