KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Sixty-Five Thousand Nine Hundred and No/100 Dollars (\$165,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **A & H, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **CORTLAND R. DUSSEAU and LYNDA DUSSEAU** (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 705, according to the Survey of Grande View Estates, Givianpour Addition to Alabaster, 7th Addition, as recorded in Map Book 21, page 134, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 1998 and subsequent years not yet due and payable.
