KNOW ALL MEN BY THESE PRESENTS,

COUNTY OF SHELBY)

That in consideration of ONE HUNDRED NINETY ONE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$191,900.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **SUE CORY, an unmarried woman**, (herein referred to as Grantor) does grant, bargain, sell and convey unto **DOUGLAS J. HILDRETH AND KAREN K. HILDRETH** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:


Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.

And we do for ourselves and for our heirs, executors, and administrators covenant with said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and my heirs, executors and administrators shall, warrant and defend the same to the said Grantees, their heirs, and assigns forever, against the lawful claims of all persons.


