

**Last Will and Testament

I, Tonya Annette Braddy, being of sound mind and disposing memory, and well knowing the true extent of my worldly possessions, do hereby make, publish and declare this instrument to be my Last Will and Testament, hereby revoking any and all other Wills and Codicils at any time heretofore made by me.

FIRST:

I direct my Executor to pay my just debts, cremation expenses, and the expenses of my last illness as soon after my demise as practicable.

SECOND:

I hereby give, devise and bequeath the following bequests:

To my beloved godson, Benjamin Seth Hampton, 2231 Pup Run, Helena, AL 35008, I give my exercise equipment, bicycle, high school band jacket, a gold ring given to me by his mother, and one fourth of my life insurance benefit and retirement funds through VALIC, for his own use absolutely and forever.

In the event Benjamin Seth Hampton predeceases me, I give, devise, and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, of whatsoever kind or nature, and whatsoever situate, of which I may die seized or possessed, or to which I may be in any way entitled to have an interest, including all property over which I have the power to appoint, to Karen Lee Mitchell, for her own use absolutely and forever.

THIRD:

To my cherished life partner, Karen Lee Mitchell, 1174 King Arthur Court, Alabaster, AL 35007, I give, devise, and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, of whatsoever kind or nature, and whatsoever situate, of which I may die seized or possessed, or to which I may be in any way entitled to have an interest, including all property over which I have the power to appoint, for her own use absolutely and forever.

In the event Karen Lee Mitchell predeceases me, I give, devise, and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, of whatsoever kind

or nature, and whatsoever situate, of which I may die seized or possessed, or to which I may be in any way entitled to have an interest, including all property over which I have the power to appoint, to Benjamin Seth Hampton, for his own use absolutely and forever.

FOURTH:

In the event that both Benjamin Seth Hampton and Karen Lee Mitchell shall predecease me, I give, devise, and bequeath all the rest, residue and remainder of my estate, real, personal and mixed, of whatsoever kind or nature, and whatsoever situate, of which I may die seized or possessed, or to which I may be in any way entitled to have an interest, including all property over which I have the power to appoint, to my brother George Arthur Braddy, Jr. for his own use absolutely and forever.

FIFTH:

A. I hereby nominate, constitute and appoint as Executor under this my Last Will and Testament, Karen Lee Mitchell. In the event that she shall predecease me, I appoint as my Alternate Executor my father George Arthur Braddy.

B. I direct that my Executor (including my Alternate) be permitted to qualify and serve without furnishing a bond or other security for the faithful performance of their duties in this or any jurisdiction.

SIXTH:

A. In the even that my Beneficiary under this Will and I should die in a common accident or disaster or under such circumstances that it cannot be established by proof who died first, then all the provisions of this Will shall take effect in like manner as if such beneficiary had predeceased me as the case may be.

B. In the event that Karen Lee Mitchell and I die in a common accident or disaster or under such circumstances that there is not sufficient evidence to determined who predeceased the other, I hereby declare that Karen Lee Mitchell shall have predeceased me and that this Last Will and Testament and any and all of its provisions shall be construed on the assumption and basis that she shall have predeceased me as the case may be.

SEVENTH:

It is my wish that at my death, my organs be donated for use by others as needed, and my remains be cremated in an inexpensive manner, and my ashes spread by Karen Lee Mitchell, along the coast of the Monterey Peninsula in California. In the event that

Karen Lee Mitchell shall predecease me, it is my wish that my father, George Arthur Braddy carry out these wishes.

IN WITNESS WHEREOF, I have hereunto set my hand and affixed my signature this fifth day of May, 1998.




