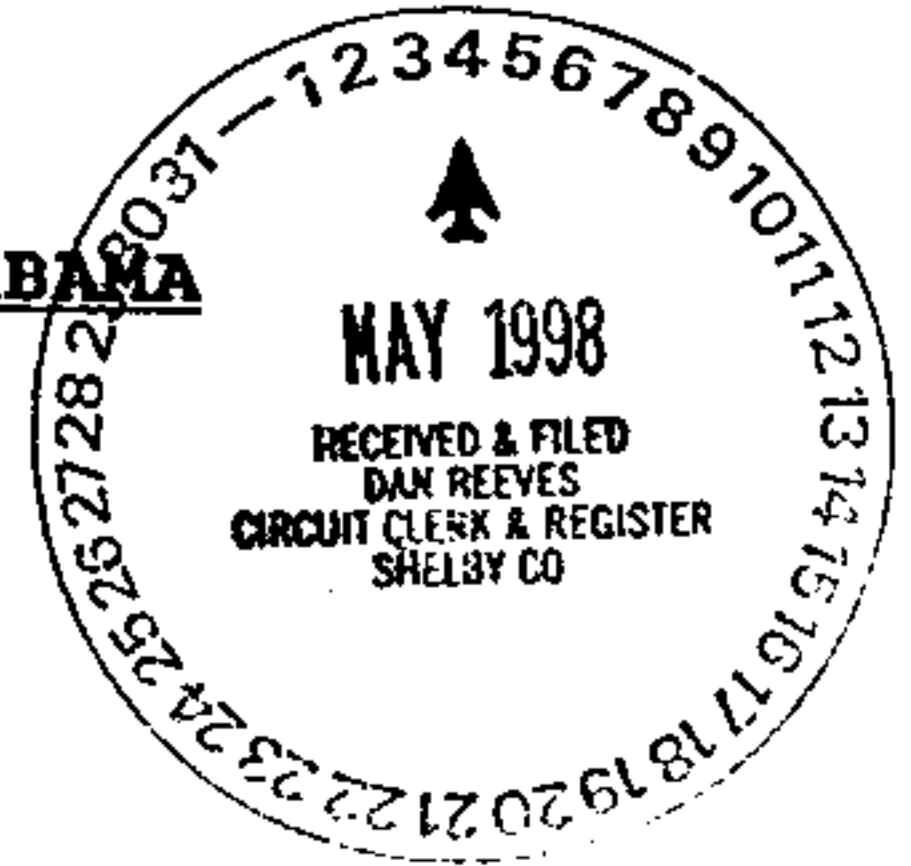

ORDERS as follows:
