THIS SUBORDINATION	AGREEMENT (this "Agreement"), dated MAY 5,	1998,

Recitals

- (jointly DAVID J. ROSS AND KIMBERLEY R. ROSS and severally hereinafter called the "Mortgagor", whether one or more) executed a certain FEBRUARY 14 in favor of the NBC and recorded in mortgage dated in the Office of the Judge of Probate of 1997/06030 County, Alabama (the "Junior Mortgage") covering certain SHELBY property more particularly described therein (the "Property").
- B. The Mortgagor has agreed to mortgage the Property to the Senior Lienor as a condition of obtaining a loan.
- C. The Senior Lienor requires that their mortgage be superior to the Junior Mortgage in order to make the loan to the Mortgagor.
- D. The Mortgagor has requested that NBC agree to subordinate the lien of the Junior Mortgage to the lien of the mortgage to be given to the Senior Mortgage.

Agreement

NOW, THEREFORE, in consideration of the foregoing recitals and in further consideration of \$1.00 and other good and valuable consideration in hand paid to NBC, the receipt and sufficiency of which is hereby acknowledged, NBC covenants and agrees as follows:

SECTION 1 Subordination. The Junior Mortgage is hereby subordinated and made junior as to the priority of its lien to the mortgage granted by the Mortgagor to the Senior Lienor covering the Property (the "Senior Mortgage"), but only to the priority of said lien and the execution of this Agreement by as NBC shall in no way impair or limit NBC's rights under the Junior Mortgage other than as expressly set forth herein.

SECTION 2 Successors and Assigns. This Agreement shall be binding upon and inure to the parties, their respective heirs, successors and assigns, and the terms "Senior Lienor," "NBC" and "Mortgagor," as used in this Agreement, shall include their respective heirs, successors and assigns.
