

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Alabama, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Document and Packaging Brokers, Inc.

ARTICLE II

OFFICE

The principal office of the corporation will be located at 10578 Highway 55, Birmingham, Alabama, 35147.

ARTICLE III

DURATION

This corporation shall exist perpetually.

ARTICLE IV

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated in Alabama.

ARTICLE V

CAPITAL STOCK

(a) Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at

any one time is 100,000 shares of voting common stock, \$.01 per share par value.

(b) **Share Classes.** The corporation is authorized to issue one (1) class of shares. These shares shall be designated as common stock. Each share of common stock shall have equal and unlimited voting rights.

#### **ARTICLE VI**

##### **INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 10578 Highway 55, Sterrett, Alabama 35147 and the name of the initial registered agent of this corporation at that address is James Allen Thompson.

#### **ARTICLE VII**

##### **DIRECTORS**

(a) **Number.** The corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by bylaws adopted by the shareholders.

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.
