

ARTICLES OF ORGANIZATION  
OF  
THE GASLIGHT HOUSE, L.L.C.

The undersigned, pursuant to Section 10-12-10 of the Alabama Limited Liability Company Act, desirous of forming The Gaslight House, L.L.C., an Alabama limited liability company (the "LLC"), do hereby certify as follows:

1. The name of the LLC shall be:

The Gaslight House, L.L.C.

2. The LLC shall have a perpetual duration unless sooner terminated by (a) unanimous consent of its Members or (b) as otherwise set forth in the Operating Agreement.

3. The purpose of the LLC shall be to:

- (a) operate an establishment known as The Gaslight House;
- (b) engage in the trade or business of the sale, either wholesale or retail, of (i) floral products, specialty gift items and household accessories or furnishings; and (ii) specialty food products;
- (c) operate a catering or banquet facility;
- (d) lease space in the facility to other commercial businesses; and
- (e) engage in the operation of any other lawful business or purpose permitted under Alabama law.

4. The location and mailing address of the LLC's initial registered office, and the name of its initial registered agent at that address shall be:

- (b) terms and conditions mutually agreeable to all Members.



- (a) unanimous written consent of the remaining Members; and
  - (b) terms and conditions mutually acceptable to all Members.
8. The LLC shall be managed by its Members.
9. The profits and losses, income, deductions and credits, and items of income, deductions and credits, of the LLC shall be allocated among the Members as set forth in the Operating Agreement.


