That in consideration of TWO HUNDRED THIRTY NINE THOUSAND FOUR HUNDRED and 00/100 DOLLARS (\$239,400.00) to the undersigned grantor, FAITH HOMEBUILDERS, INC., (hereinafter "grantor"), in hand paid by the grantee herein, the receipt whereof is acknowledged, grantor, does grant, bargain, sell and convey unto JOHN M. HILL AND NANCY T. HILL, as joint tenants with rights of survivorship ("grantees"), all of its interest in the following described real estate, situated in Shelby County, Alabama:

Lot 71, according to the Survey of Eagle Point, 12th Sector, Phase II, as recorded in Map Book 23, Page 82, the Probate Office of Shelby County, Alabama.

\$215,000.00 of the consideration is from a purchase money first mortgage.


