

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED NINETY NINE THOUSAND AND NO/100 DOLLARS (\$299,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **EARLE B. MAY, III AND WIFE, SALLY P. MAY**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **JAMES G. JASINSKI AND JULIE JASINSKI** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:


Subject to existing easements, restrictions, set back lines, rights of ways, limitations, if any, of record.


\$284,000.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.


